**Treasurer's report:** Sue Milgrom read the Treasurer's report and reported a current balance of \$3,010.23 (report attached). Otto Henderson made a motion to approve the report and Susan Reid seconded. The motion carried. Members were reminded to pay their dues and advised that the membership roster would be updated to reflect those members with paid dues.

**State Director's Report**: Randall Haydon advised due to the Coronavirus the Region 3 Rally was cancelled and Nappanee was doing scheduled service but was not taking new service orders or holding plant tours at this time.

**Old Business:** Kathleen Haydon advised that the KLSS audit would be performed prior to the next meeting.

- Upcoming Rallies:
  - Winstar Rally in Thackerville, OK At this time it was advised that the rally would still be held.
  - State Rally in Mineola Kathleen Haydon advised that the State rally would be held at the Mineola Civic Center RV Park April 30 through May 1<sup>st</sup> which is the weekend of 1<sup>st</sup> Monday in Canton. Kathleen advised that the cost for the rally would be \$175 per rig, which does not include RV sites, but would include entertainment one night. Members were advised to call and make their RV reservations.

- October Rally The October rally is scheduled for October 15-17<sup>th</sup> at Matagorda Bay Nature Park and RV Park (Lower Colorado River Authority park). Members were advised to make their reservations with the park.
- Shirts Kathleen Haydon advised that members had previously requested KLSS shirts. She presented two samples, one grey (unisex) and one blue (women's) and advised that we could sell them for \$15. Depending on the actual cost, the proceeds back to the chapter would be approximately \$7-8 per shirt. The proceeds could then be used for an unidentified charity to be determined. If someone wants the shirts shipped instead of picking them up at the next meeting a \$5 shipping charge would be added. Diana Fickinger made a motion to place orders for the shirts and use the proceeds for an unidentified charity, Danny Reid seconded and the motion carried.
- **50/50 Rally** Kathy advised that the club previously voted to hold a 50/50 rally at each rally to benefit an unidentified charity. Kathy Hutchens made a motion to carry forward with this idea and the motion carried. Danny Reid suggested that we do this in the interim and update the chapter rules.
- **Chapter Rules** Kathy Hutchens advised that a committee would be formed to update the KLSS Chapter Rules and that Danny Reid has agreed to chair the committee and she would be an ex-officio member.
